APPEARANCE

White pellets; Garlic or carbide odour.

DANGER

Toxic: inhalation, ingestion or contact (skin, eyes) with vapors, dusts or substance may cause severe injury, burns or death.

Reaction with water or moist air may release toxic, corrosive or flammable gases.

Fire will produce irritating, corrosive and/or toxic gases.

PERSONAL PROTECTIVE EQUIPMENT

Protective goggles or face shield. Protective gloves. Protective shoes. Respiratory safety device that will allow driver to escape.

EMERGENCY RESPONSE EQUIPMENT

Chemical protective clothing that is specially recommended by the manufacturer. Shovel. Positive pressure self-contained breathing apparatus (SCBA). CO₂ (except for Cyanides), dry chemical, dry sand, alcohol-resistant foam.

DRIVER FIRST ACTIONS - Contact emergency services. Keep upwind. No smoking. Keep unauthorized personnel away.

DRIVER SPECIAL/ADDITIONAL ACTIONS - DO NOT GET WATER INSIDE CONTAINERS. Stop leak if you can do it without risk. Prevent entry into waterways, sewers, basements or confined areas.

DRIVER ACTIONS IN CASE OF FIRE – Move containers from fire area if you can do it without risk. Fight fire from maximum distance or use unmanned hose holders or monitor nozzles. Dike fire-control water for later disposal; do not scatter the material.

FIRST AID

Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Effects of exposure (inhalation; ingestion; or skin contact) to substance might be delayed. Move victim to fresh air.

SPECIAL INFORMATION FOR EMERGENCY SERVICES

Reaction with water may generate much heat that will increase the concentration of fumes in the air. Ventilate enclosed areas. Fire will produce irritating, corrosive and/or toxic gases.
