## **PRECAUTIONS:**

- Observe all precautions that are applicable to products with which BOOSTER AS will be used.
- Prevent drift of spray mist onto other crops, grazing, rivers, dams or areas not under treatment.
- Triple rinse empty containers in the following manner: Invert the empty container over the spray or mixing tank and allow to drain for at least 30 seconds after the flow has slowed down to a drip. Thereafter rinse the container three times with a volume of water equal to a minimum of 10% of that of the container. Add the rinsings to the contents of the spray tank before destroying the container in the prescribed manner.
- Empty containers should be taken for local recycling or waste disposal.
- Do not re-use empty containers.
- Prevent contamination of food, feedstuffs, drinking water and eating utensils.

## **FIRST AID TREATMENT:**

**INHALATION:** Remove person to fresh air and keep comfortable for breathing.

**INGESTION:** Rinse mouth with water. Seek medical attention.

**EYE CONTACT:** Rinse cautiously with water for several minutes.

## **DIRECTIONS FOR USE:** Use only as directed.

### **Dosage:**

Use 2ℓ BOOSTER AS per 100ℓ spray mixture.

### **Mixing Instructions:**

- (a) Half fill the spray tank with clean water, start agitation and add required amount of BOOSTER AS.
- (b) Add the correct amount of flowable herbicide, glyphosate and remaining water with continual agitation.
- (c) Should a wetter be required, add this last.
- (d) Maintain adequate agitation during application and do not leave the tank mixture to stand for any length of time.

**NOTE:** The use of BOOSTER AS will increase glyphosate efficacy by improving its uptake and aid compatibility with certain other herbicides.
