APPEARANCE

Liquid; Clear light yellow; Perceptible odour.

DANGER

Ingestion of material may be harmful.
Inhalation of material may be harmful.
Contact may cause burns to skin and eyes.
Containers could explode when heated.

PERSONAL PROTECTIVE EQUIPMENT

Protective goggles or face shield. Protective gloves. Protective shoes. Eyewash bottle with clean water.

EMERGENCY RESPONSE EQUIPMENT

Dry chemical, CO₂, water spray or regular foam. Chemical protective clothing that is specially recommended by the manufacturer. Sand or other absorbent. Shovel.

DRIVER FIRST ACTIONS - Contact emergency services. Keep upwind. No smoking. Keep unauthorized personnel away.

DRIVER SPECIAL/ADDITIONAL ACTIONS - Stop leak if you can do it without risk. Dike far ahead of liquid spill for later disposal. Prevent entry into waterways, sewers, basements or confined areas.

DRIVER ACTIONS IN CASE OF FIRE - Move containers from fire area if you can do it without risk. Dry chemical, CO₂, water spray or regular foam. Do not scatter spilled material with high-pressure water streams.

FIRST AID

Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. In case of contact with material; immediately flush skin or eyes (or both) with running water for at least 20 minutes. Move victim to fresh air. Give artificial respiration if victim is not breathing. Remove and isolate contaminated clothing and shoes.

SPECIAL INFORMATION FOR EMERGENCY SERVICES

Fire may produce irritating, corrosive and/or toxic gases. Some liquids produce vapors that may cause dizziness or suffocation. Dyke fire control water for later disposal.
