DANGER

Harmful if swallowed. May cause an allergic skin reaction. Harmful if inhaled. Causes damage to organs through prolonged and repeated exposure. Very toxic to aquatic life with long lasting effects.

PERSONAL PROTECTIVE EQUIPMENT

Protective goggles or face shield. Protective gloves. Protective shoes. Eyewash bottle with clean water. Respiratory safety device that will allow driver to escape.

EMERGENCY RESPONSE EQUIPMENT

Chemical protective clothing that is recommended by the manufacturer. Dry chemical or CO₂. Shovel.

DRIVER FIRST ACTIONS - Contact emergency services. Keep upwind. No smoking. Keep unauthorized personnel away.

DRIVER SPECIAL/ADDITIONAL ACTIONS - Stop leak if you can do it without risk. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Prevent entry into waterways, sewers, basements or confined areas.

DRIVER ACTIONS IN CASE OF FIRE - Fight fire from maximum distance or use unmanned hose holders or monitor nozzles. Dike fire-control water for later disposal; do not scatter the material. Move containers from fire area if you can do it without risk.

FIRST AID

Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. In case of contact with material; immediately flush skin or eyes (or both) with running water for at least 20 minutes. Move victim to fresh air. Remove and isolate contaminated clothing and shoes.

SPECIAL INFORMATION FOR EMERGENCY SERVICES

Runoff from fire control or dilution water may be corrosive and/or toxic and cause pollution. Containers may explode when heated.
